Attached is the Company's appendix 4C for the quarter ended 30 June 2008.

The Company's cash balance as at 30 June 2008 was \$ 215,000. Since that date, the Company has received a milestone payment of \$ 75,000 (28th July 2008), and has also agreed to an underwriting proposal from stockbrokers Taylor Collison Ltd to conduct a placement (equivalent to 15% of the Company's issued capital) to raise \$ 300,000 at one cent per share. These funds will be sufficient to cover the net operational cash outflow for at least the next two quarters.
