REPORT FOR THE QUARTER ENDED 31 DECEMBER 2021

Bioxyne Limited (ASX Code: BXN) (Bioxyne or the Company) is pleased to report on its activities for the quarter ended 31 December 2021.

Highlights

- **Positive operating cash flow for the quarter and half year**
- **Cash increased to \$2 million at quarter and half year end**
- **Revenues 50% up quarter on quarter previous year and +12% up for 1H**
- **Firm orders for PCC probiotics received for 2H FY 2022**
- **First shipment to Asia of ColosNZ Pro delayed by shipping logistics to February 2022**

Results

Sales revenue (unaudited) for 1H FY 2022 was \$1,358k (1H FY 2021: \$1,211k), +12% up on the previous half year. A shipment of ColosNZ to Asia (\$312k) was delayed to February 2022 given ongoing difficult international shipping conditions.

Wholesale sales of *Lactobacillus fermentum* PCC® remains strong (+38% up on 1H FY2021) and the outlook remains positive for this key immune boosting ingredient in probiotics in this COVID environment. The direct sales business in Indonesia continues to grow modestly and the Company continues to seek opportunities to expand distribution in other Asian countries for its product range.

The unaudited result for the half year is estimated to be a modest profit of \$5k (1H FY2021: Loss of \$284k), the improvement attributable to increased sales revenue and effective cost cuts necessitated by the COVID hiatus.

The Company achieved positive Operating Cashflow of \$317k for the quarter and \$362k for the half year. Cash at the end of the quarter \$2.07m.



Operations

Wholesale sales of *Lactobacillus fermentum* PCC® were the major contributor to revenue, with Indonesia repeating its modest Q1 result bringing its revenue to \$83k for the half year.

The order of ColosNZ to South East Asia with value ~\$312k was further delayed given shipping difficulties and will now be shipped in Q3 FY2022.

The Company has successfully completed a colostrum coffee pilot production during the quarter and the first commercial order is expected in Q3 FY 2022.

Progastrim™ (PCC®) - clinically tested proprietary patented probiotic, for general gut health and immune support

Mymana™ – colostrum and fortified milk formula for nutrition and immune support

ColosNZ™ – enhanced colostrum and fortified milk formula for nutrition and immune support

Col-Coffee™ - Colostrum three in one powder coffee mix

BK18™ – NZ dairy-based formula with probiotics and vitamins for general health and immune support

Allura™ – weight management and beauty drink for women

Mustang™ – weight management and vitality shake for men

New business opportunities focus

The Company is actively seeking acquisitions of businesses or products to broaden its operating base which would build shareholder value. During the quarter the Company identified an opportunity and completed commercial and technology due diligence but concluded that it was not a suitable fit for the Group at this time.

Corporate

Cash on hand as at 31 December 2021 was \$2.07 million.

Payments to related parties and their associates during the quarter of \$65,000 comprise director and non-executive director salaries, fees and superannuation.
